## NOTICE OF SCHOLARSHIP OPPORTUNITY FOR SHAREHOLDERS

### **Introduction**

As part of its values to promote excellence, MRS Oil Nigeria Plc seek to help our shareholders and staff achieve the highest levels of scholastic excellence they dream for their children with a rewarding scholarship scheme.

The goal of the scheme is to financially support academically outstanding and less privileged children of our shareholders and staff.

The scholarship will be awarded to Senior Secondary Students in SS1 to SS3, who attend a government or recognized and accredited private higher secondary school in Nigeria. Scholarship will also be awarded to undergraduates who have been offered admission into government or recognized and accredited private or university/polytechnic/monotechnic, for the duration of their course.

### **Eligibility Requirements**

#### **Secondary School Applicants**

1. Scholarship will be awarded to the senior secondary students who have concluded the Junior Secondary School (JSS) 3 examination and have a minimum of five (5) distinctions in the relevant subjects (including Mathematics and English Language) at the JSS examination, in one sitting.
2. Applicants must be a child of a registered shareholder of MRS Oil Nigeria Plc.
3. Applicants must have the JSS result available as at the date of submitting the application.
4. Senior secondary students must not be more than 18 years old at the start of the academic session.
5. Applicant must be a Nigerian.
6. Applicant must not be a beneficiary of another scholarship.
7. Application will only be considered for fresh students (i.e. students who have just gained admission into SSS 1).

#### **Undergraduate Applicants**

1. Scholarship will be awarded to students who have completed their Senior Secondary School (SSCE) examination (or its equivalent in NECO, at one sitting) with a minimum of five (5) distinctions (A1) in five subjects (including English language) relevant to the course of study in the higher institution of choice (with at least a credit in Mathematics).
2. Applicants must be a child of a registered shareholder of MRS Oil Nigeria Plc.
3. Applicants must have been offered admission into any recognized tertiary institutions (university/polytechnic/monotechnic).
4. Be admitted in a recognized career course.
5. Applicants applying for higher institution scholarship should not be more than 25 years old at the start of the academic session.
6. Applicant must be a Nigerian.
7. Applicant must not be a beneficiary of another scholarship.
8. Application will only be considered for fresh students (i.e. students who have just gained admission into year 1 or year 2 via direct entry).



**Undergraduate Applicants should note the following conditions below:**

INSTITUTION TYPE	QUALIFICATION	DURATION	REMARK
UNIVERSITY	BSC, BENG, BA, etc.	Approved duration of each course	Scholarship award shall not be given beyond the number of years approved for each course in the university.
POLYTECHNIC	OND/HND	Four (4) years	Applicants from a polytechnic will only be allowed to apply from the first year of the OND programme, which will be carried through the HND programme (same school and same programme). No new application will be considered for HND programme.
MONOTECHNIC	NCE, etc.	Three (3) years	Scholarship award shall not be given beyond three (3) years.

**Application Procedure**

2. Download and complete the application form. Please note that the completed application form must be endorsed by the School.
3. All scholarship applications must be submitted electronically (including completed application form, scanned copies of relevant credentials) to [monscholarship@mrsholdings.com](mailto:monscholarship@mrsholdings.com)
4. The following documents must be scanned and attached to email application:
  - Nigerian Passport
  - Birth Certificate/affidavit – affidavit date must not be earlier than 60 days from the date of application
  - Admission Letter
  - JSS Result
  - SSCE Result
  - Academic Result
5. The subject of the application should read – ‘MON SCHOLARSHIP APPLICATION (APPLICANT NAME)
6. Application opens on **October 4<sup>th</sup>** and closes on **November 4<sup>th</sup>, 2016**.
7. Applications that does not meet the requirements or does not follow the recommended procedure stated above will not be considered.
