Eligibility Requirements

Secondary School Applicants

1. Scholarship will be awarded to students who have completed the Junior Secondary Certificate Examination (JSCE), and have a minimum of five (5) distinctions i.e. A, which is equivalent to excellent grading system in the relevant subjects (with at least credit in Mathematics and English Language) at one sitting
2. Applicant must have the JSCE results available during the application period
3. Applicant should not be more than 18 years old as at the time of application
4. Applicant must be a Nigerian
5. Applicant must be a child of a confirmed employee of MRS Oil Nigeria Plc during the application period
6. Applicant must not be a beneficiary of another scholarship

Undergraduate Applicants

7. Scholarship will be awarded to students who have completed the Senior Secondary Certificate Examination (SSCE) or its equivalent in NECO and GCE. The applicant must have a minimum of five (5) distinctions i.e. A, which is equivalent to excellent grading system in the five subjects relevant to the course of study in the higher institution of choice (with at least a credit in Mathematics and English Language) at one sitting
8. Applicant must have been offered admission into an approved tertiary institution (University/Polytechnic/Mono-technic) in Nigeria
9. Applicants should not be more than 25 years old during the application period
10. Applicant must be a Nigerian
11. Applicant must be a child of an individual employee of MRS Oil Nigeria Plc during the application period
12. Applicant must not be a beneficiary of another scholarship

POLYTECHNIC Click to view the list of NBTE accredited Polytechnics in Nigeria	OND/HND	Four (4) years	Applicants from a polytechnic will only be allowed to apply from the first year of the OND programme, which will be carried through the HND programme (same school and same programme). No new application will be considered for HND programme.
MONOTECHNIC Click to view the list of NBTE accredited Monotechnics in Nigeria	NCE, etc.	Three (3) years	Scholarship awards shall not be given beyond three (3) years.
